



PROGRAM DETAILS

- **Eligibility**

To be eligible for the BENTLEY “Military and First Responder Appreciation Program” (“Program”), an Eligible Purchaser (as defined below) must purchase a New Model Year 2023/2024 (“New” is unused and not previously warranty registered) BENTLEY boat, with a BENTLEY invoiced outboard motor from a participating authorized BENTLEY dealer during JULY 2023 to JUNE 2024 (“Program Period”) and meet the other requirements of the Program.

- **An Eligible Purchaser includes the following:**

- (i) U.S. Armed Forces personnel that are on active duty, honorably discharged or retired.
- (ii) First responders who are active, including Firefighters, Law Enforcement (including state troopers, sheriffs, sheriff deputies and local police officers), Emergency Medical Technicians and Paramedics within an Emergency Medical Service.

- An Eligible Purchaser must provide proof of service to the authorized BENTLEY dealer, through a valid ID, proof of service letter, or DD214 Form, acceptable to BENTLEY, showing proof of being an Eligible Purchaser (“Proof of Service”).

- **OFF-INVOICE DISCOUNT:**

\$500 on any two tube FISH, LEGACY or ELITE (20’ and larger) or \$1,000 on any triple tube FISH, LEGACY or ELITE (20’ and larger) AND A \$100 gift certificate for the Bentley Boat Store. LE models do not qualify.

AFFIDAVIT

The Eligible Purchaser attests that they meet the Program requirements, as follows:

(i) I purchased a Qualified BENTLEY Boat Package from a participating authorized BENTLEY boat dealer during the Program Period.

(ii) I am an Eligible Purchaser and have provided Proof of Service to the BENTLEY authorized dealer.

To receive the incentive, as noted, 1) an Affidavit must be completed by an Authorized BENTLEY Dealer and sent to BENTLEY Boats, along with 2) a copy of the final Bill of Sale and 3) confirmation of Proof of Service as noted by the BENTLEY dealer’s signature to the Affidavit.

*After final verification by BENTLEY of Program eligibility and receipt of Affidavit, any eligible Incentive will be immediately taken off the purchase price. Limit (1) Off-Invoice discount Eligible Purchaser. BENTLEY Boats reserves the right to modify or terminate the “Military and First Responder Appreciation Program”, in its sole discretion, at any time, without incurring any obligations. Void where prohibited by law. Other restrictions may apply. Not redeemable for cash. This offer is not transferrable. All matters of Program eligibility will be determined by BENTLEY, within its sole discretion. Photocopying of US government ID cards is a violation of 18 U.S.C. § 701.
